
## **IMPORTANT INSTRUCTIONS**


GENERAL WARNING: When using electrical appliances, basic precautions should always be followed to reduce the risk of fire, electrical shock and injury to persons, including the following:

- **ALWAYS** UNPLUG UNIT BEFORE CLEANING.

- **DO NOT** PLACE FAN OR ANY PARTS NEAR AN OPEN FLAME, COOKING OR OTHER HEATING APPLIANCE.
- **DO NOT** OPERATE THIS UNIT WITH A DAMAGED CORD OR PLUG, ESPECIALLY IF THIS UNIT HAS BEEN MALFUNCTIONING, DROPPED OR DAMAGED.
- MAKE SURE FAN IS ON A STABLE, FLAT SURFACE WHEN IN OPERATION.
- III CLOSE SUPERVISION IS NECESSARY WHEN THIS UNIT IS USED BY OR NEAR CHILDREN.
- 12 ALWAYS HOLD THE FAN FROM THE BOTTOM OF THE HOUSING WHEN RELOCATING THE FAN. PULLING OF THE CORD OR LIFTING THE FAN BY THE TOP COVER MAY DAMAGE THE FAN.
